A discipline history report will be provided.	<b>Suspension WARNING</b> 5 Credit Penalty for Lost or Forgotten Tracking Chart Failure to meet with guidance counselor as specified will result escalate this incident to the next disciplinary step. Negative account balances must be rectified by weekend volunteer service hours.

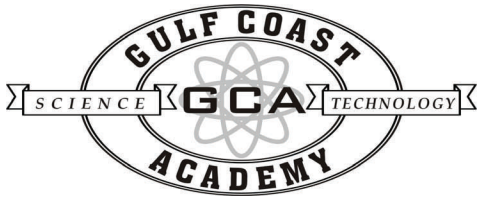
